



Expectations of construction enterprises in IV quarter 2023 regarding the development of their business activity


Construction confidence indicator¹




Assessment of the current order-books (seasonal adjustment)

Expected changes in prices of work performed by construction enterprises





¹ The indicator is calculated by the method of calculation of indicators of business expectations, approved by order of the SSSU of 03 December, 2021 No 301 (with changes).


Factors limiting building activity
