





Expectations of industrial enterprises in September 2023 regarding the development of their business activity

Expected changes of industrial production over the next 3 months (seasonal adjustment)






Assessment of current stock of finished products in industry




Assessment of industrial production in the past 3 months




Assessment of current export order-books (export demand) on the industrial production




Expected changes in selling prices for the products of industry over the next 3 months
