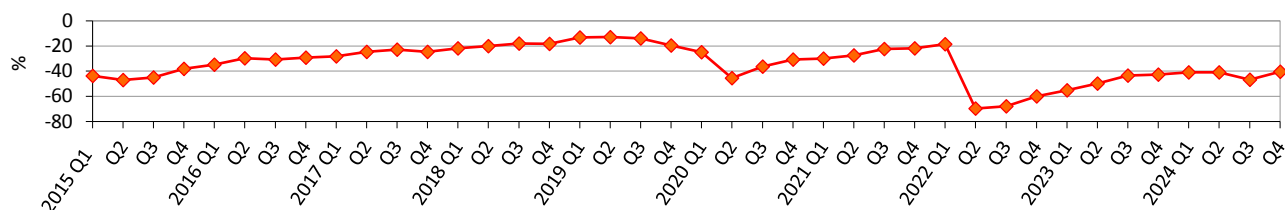
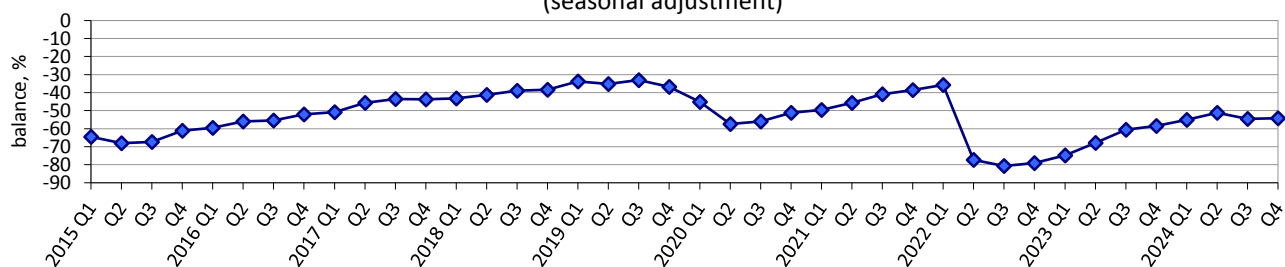


Expectations of construction enterprises in IV quarter 2024 regarding the development of their business activity

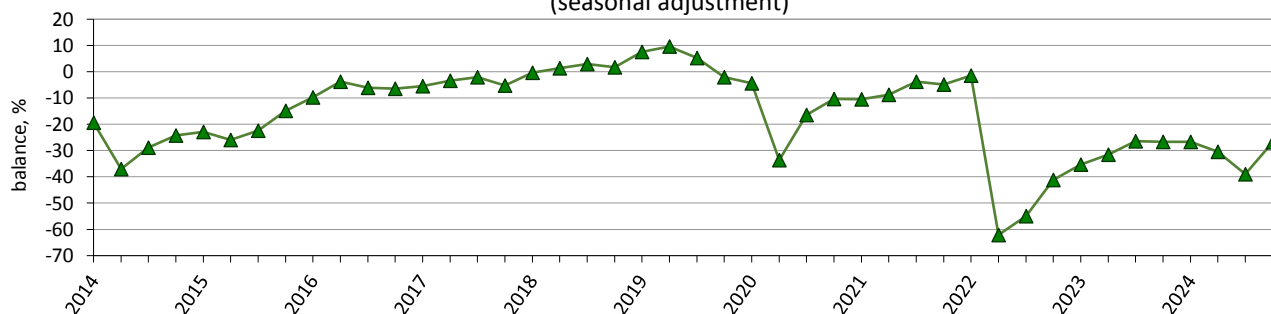
Construction confidence indicator¹



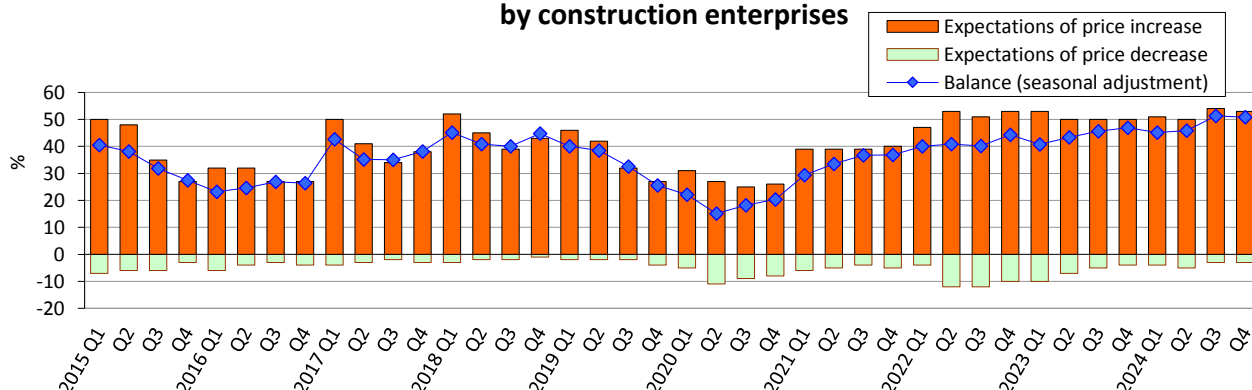
Assessment of the current order-books (seasonal adjustment)



Expected changes in employment at construction enterprises (seasonal adjustment)



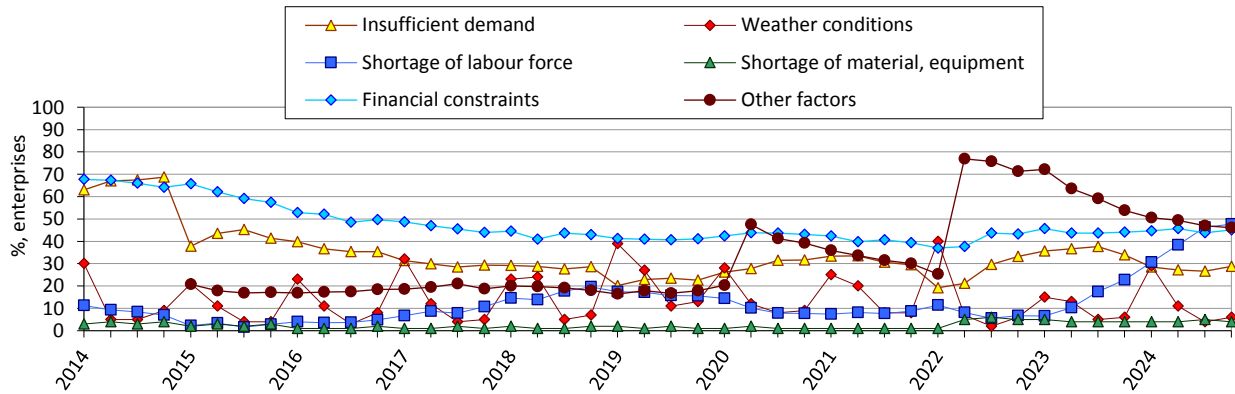
Expected changes in prices of work performed by construction enterprises



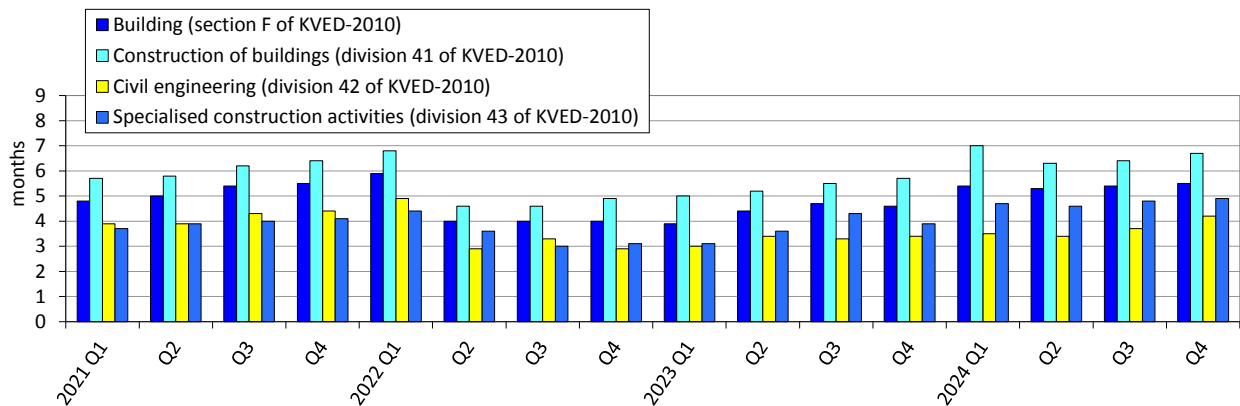
