





(seasonal adjustment)**



Information for II quarter of 2022 – III quarter of 2024 has been compiled on the basis of reports actually submitted by enterprises.



Expected changes in employment at service enterprises




Expected changes in service price at service enterprises



Factors limiting activity in services




Financial services confidence indicator¹


